Please return your application, check, and signed release forms, as soon as possible to ensure your 2018 space. If we have not received your application and check by October 3, 2018 your space will be filled by new vendors on a first come basis. Also, fees increase by \$10 after October 3, 2018 so make sure you return this to me as soon as possible.

2018 Rental Agreement

1. The bazaar starts at 9:00 am and ends at 3:00 pm on Saturday, November 3, 2018. You may not, under any circumstances, tear down before 3:00 pm. Set-up is Friday, November 2 from 6:00 pm - 8:00 pm and Saturday, November 3 from 7:00 am - 9:00 am.
2. Vendors setting up Friday evening are required to sign a release of liability, which is on the application. Make sure you read the release before you sign on the application.
3. Spaces are approximately 8' x 8', but may vary. Your display must remain in your space, if this is not an efficient amount of space, please rent an additional one.
4. The vendor must provide all necessary display equipment. The vendor must agree to remove any part of their display that's deemed inappropriate to St. Pius X Pastoral Advisory Council.
5. Vendors are solely responsible for all financial transactions connected with their merchandise.
6. No food of any kind is permitted to be sold at the Bazaar.
7. Vendors must comply with parking in the designated "vendor parking" area. Vendor Parking will be in the Children Center Lot and to the far Southwest area of the Parking lot.
8. St. Pius X Church, its affiliated organizations, and their members are not responsible for any damages, loss or theft of merchandise or display equipment.
9. St. Pius X Pastoral Advisory Council agrees to publicize this event through various types of media in and around the area.
10. A rental fee of \$45 for each space is required before October 3. After October 3, fees increase by \$10. Electrical Cost is an additional \$10.
11. Each space will be provided with an 8'' table and two chairs. Unless you have not requested a table.
12. Applicants need to return the following by October 3, 2018:
 1. Application with signatures.
 2. Check for the rental fee and tables.
 3. Pictures of craft
13. Previous vendors will be given the opportunity to register before new vendor applications are accepted.
- 14. There will be no refunds for cancellations.**

We feel these regulations are necessary to insure a successful bazaar for all of our vendors. Please keep this list and refer to it before the bazaar.

**A confirmation email will be sent out upon approval into the Craft Bazaar. Spaces will be filled on receipt of application and approval of committee.
